The Crystal Cup European Cross Country Challenge is an initiative that brings together the finest international horses and riders to reward the most successful stable in cross country steeple chasing. The best owner and trainer will be rewarded with the following bonuses:

- Owner: € 25.000 for the first - € 10.000 for the second
- Trainer: € 10.000 for the first - € 5.000 for the second

The 12 race series, with over € 850.000 in prize money, will be hosted by many of Europe's premier racecourses, over unique combinations of hedges, banks, ditches and timber.

The Challenge begins in Waregem in Belgium in September 2025. The final race is at Lion D'Angers in May 2026 after races in France and visits to Italy, the Czech Republic, Ireland, England and Poland.

PRIX FELIX DE RUYCK - HAIES

HANDICAP - 3600 M

(€40.000) €20.000 - €10.000 - €5.000 - €2.500 - €1.500 - €1.000

Entry and forfeit: Following the France Galop rules

For 4 year old and upwards who were placed in the first four of a hurdle race, a steeple- chase a point-to-point or a cross since 1/07/24.

Minimum weight: 62 kg.

Each horse winning after the publication of the weights remains qualified but will carry a penalty of 3 kg.

PRIX BARON CASIER - LAURENT PERRIER

STEEPLE-CHASE - 3950 M

(€40.000) €20.000 - €10.000 - €5.000 - €2.500 - €1.500 - €1.000

Entry and forfeit: Following the France Galop rules

For 4 and 5 years old who have been placed in the first four in a steeple-chase, a point-to-point or a cross since 1/01/24.

Weight 4 year old: 63 kg - Weight 5 year old: 65 kg

Penalties for all sums (first prize money and placed) obtained in steeple-chase, a point-to-point or cross: 1 kg per € 8.000 this year and per € 16.000 last year.

The waterjump will be jumped once and the bank once. Every participating horse finishing out of the first five will be allocated a premium of € 500.

ING GRAND STEEPLE CHASE OF FLANDERS

HANDICAP - REF. +3 4600 M

(€100.000) €50.000 - €25.000 - €12.500 - €6.000 - €4.000 - €2.500

Entry and forfeit: Following the France Galop rules

For 5 years old and upwards who have won a steeple chase, a point-to-point or a cross, and were placed in the first five of a steeple-chase, a point-to-point or a cross since 1/01/24. Horses having finished in the first three of a Crystal cup race in 2024 or 2025 will also be qualified.

French horses will be handicapped based on the French General Handicap increased by 3 kilos, without prejudice to the right of the handicapper to deviate from the last published handicap mark.

Minimum weight: 62 kg.

The waterjump and the bank will be jumped twice. Each horse winning after the publication of the weights remains qualified but gets a penalty of 3 kg.

HANDICAP - REF. +13 4600 M

(€50.000) €25.000 - €12.500 - €6.000 - €3.000 - €2.000 - €1.500

Entry and forfeit: Following the France Galop rules

For 5 years old and upwards who have won a steeple chase, a point-to-point or a cross, and were placed in the first five of a steeple-chase, a point-to-point or a cross since 1/01/24.

French horses will be handicapped based on the French General Handicap increased by 13 kilos, without prejudice to the right of the handicapper to deviate from the last published handicap mark.

Minimum weight: 62 kg.

The waterjump and the bank will be jumped twice.

Each horse winning after the publication of the weights remains qualified but gets a penalty of 3 kg.

Entries must be made by writing, telefax or e-mail :

Each first entry made in Belgium must contain the exact description of the horse entered, his name, age, sex and breeding. The name, the address and colors of the owner as well as the name and the address of the trainer. The entry must be accompanied by a certificate mentioning the amount of prize money won since 1/01/24 and the latest 4 performances of the horse.

Every horse that was not born in Belgium, is only admitted to run on presentation of the following documents:

1. A certificate mentioning the name, breeding, age, sex and color of the horse and the visual natural or accidental marks of the horse. This certificate must be signed by the authorities of the country where the horse was born or otherwise the authorities of the country where the horse has been staying where the qualifications are similar in their own country with those of the Belgian Jockey Club.
2. This document must be together with a sanitary certificate established following the local rules of the local country.
3. A certificate mentioning that the horse has incurred no disqualification or is not on a forfeit or similar list. Certificate to be signed by the authorities mentioned before (Racing Clearance Notification-RCN).

Horses coming from abroad must be vaccinated against flu and rhinopneumonia corresponding to the rules of France Galop before they are allowed into the stables of the racecourse.

GENERAL CONDITIONS

Races are governed by the Code and Regulations of France Galop, as well as by the general conditions below:

Anyone who enters, races, or has any interest in the ownership of a horse entered or racing in a public race, anyone subject to the provisions of the Code and regulations, anyone allowed to use the race and training grounds of the Royal Society of Races of Waregem, is deemed to know the Code and Regulations of France Galop. They thereby submit to all their provisions and all the consequences that may result from them, as well as to the decisions of the Belgian Jockey Club, its Committee, the Race Commissioners, and the Committee of the Royal Society of Races of Waregem, in particular regarding the limitation of the number of starters in each race. Any entry received after the fixed time is null and void, even if the delay is justified by reasons of force majeure.

No fine will be imposed on a horse declared to start and unable to race for health reasons, provided a veterinary certificate is issued.

FOR ALL THE RACES IN THIS PROGRAMME THE MAXIMUM NUMBER OF HORSES PER RACE WILL BE 14.

If the number of declared runners is greater than 14, the following rules will apply in order to choose the effective runners.

A. In the condition races

The withdrawal of declared runners will be made in the following order in order to reach 14 declared runners:

1. Horses who have been supplemented by an supplementary entry.
2. Horses with the lesser money won (win and places) since 1/01/24, starting with the lowest amount and going upwards. In the case of equal amount between two or more horses, there will be a draw.

B. In the handicap

The withdrawal of declared runners will be made in the following order in order to reach 14 runners. Firstly, the horses with the lowest weight as attributed by the handicapper when the weights were published, starting with the lowest weight and going upwards, taking into account weight for age. In the case two or more horses carry the same weight, priority will be given to the horses who have finished in the first four of a race run in Waregem on the 27th of August 2024 and then by eliminating the horses with the lesser money won (win and places) since 1/01/24.

In the case these criteria cannot split two horses, there will be a draw. The stewards of the races are allowed to change the weights until the moment of declaration of the starters.

The entry fee paid for the horse declared running and not taking part will be multiplied by 4.

BLINKERS & AUSTRALIAN BLINKERS

Are forbidden.

WEARING OF A CRASH HELMET

No person is admitted to ride in one of the races in this programme, when not wearing a crash helmet equipped with a chinstrap according to the model approved by the Belgian Jockey Club.

WEARING OF A BODY PROTECTOR

No person is admitted to ride in one of the races in this programme, when not wearing a body protector according to the model approved by the Jockey Club.

JOCKEYS

To be qualified jockeys must have won 3 jump races since 01-07-2024. No claims are allowed to the jockeys.

HANDICAPS

The stewards of the Royal Waregem Racing Society have the authority to increase the weights at the declaration of the likely starters so that the top weight carries a maximum of 70 kilograms.



DOPING CONTROL

The doping control will be handled by the laboratory of Verrières - le - Buisson (FR). A second analysis will be done by one of the laboratories proposed by the Jockey Club, and chosen by the trainer.

VET CHECK BEFORE THE RACES

The decision of the vet appointed by the Royal Waregem Racing Society is irrevocable. A counter expertise by an external veterinarian cannot be requested.

TRAINING

Training on the jumps of the racecourse is forbidden, except on the Monday preceding the racing day and in the morning of the racing day, when it will be allowed to jump the movable hurdle and the bank.
